

MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING ("MOU"), is made by and between the GOVERNOR OF THE STATE OF NEW YORK, and the undersigned LEGISLATIVE LEADERS, or their designees.

WHEREAS, this MOU is entered into in order to identify projects ("Projects") eligible for funding from certain provisions of the Clean Water/ Clean Air Bond Act of 1996 ("Bond Act") in accordance with the provision set forth in Section 32 of Chapter 413 of the Laws of 1996; and

WHEREAS, this MOU is also intended to set forth the reporting requirements, agreed as necessary, relative to any such funded Projects; and


WHEREAS, this MOU shall supersede the prior MOU between the Governor and the Legislative Leaders dated March 24, 2003;

NOW, THEREFORE, in consideration of the premises and mutual and covenants set forth herein, it is agreed as follows:

1. Appendix A to this MOU sets forth the Water Quality Improvement Projects which have been determined to be eligible for funding by the New York State Department of Environmental Conservation ("DEC") to implement the Long Island Sound Comprehensive Conservation and Management Plan and to support a study of groundwater quality on Long Island. This includes seventy-five million, one hundred fifty-two thousand, sixty-two dollars, (\$75,152,062) and an additional eight million, four-hundred twenty-three dollars (\$8,000,423) is available for projects to be agreed to pursuant to an MOU by the Governor and Legislative Leaders from State Fiscal Year 2000-01, 2001-2002 and 2002-2003 appropriations. These Projects have been recommended for funding by staff from DEC.
2. If either or both of the Legislative Leaders request in writing, DEC shall provide to the Legislative Leaders, or their designees, copies of all written correspondence relating to each Project funded by such appropriations or subsequent re-appropriations; provided, however, that proprietary information may be withheld from such correspondence if the Legislative Leaders, or their designees, are given notice that such information has been withheld.
3. DEC shall respond promptly to all inquiries by the undersigned Legislative Leaders, or their designees, regarding any Project listed in Appendix A.
4. DEC shall provide to the undersigned Legislative Leaders, or their designees, prompt and timely notice, at least one week in advance, of all public proceedings or announcements relating to each Project funded by such appropriations or subsequent re-appropriations, provided that such proceeding is scheduled one week in advance, otherwise at the earliest time practicable. Such notice shall include an invitation to attend and participate in the proceedings or announcements.


5. This MOU, including Appendix A, may not be amended except by written agreement of the Governor and all the undersigned Legislative Leaders.


